

City of Burns Request for Bids – Fuel Tank

City of Burns ("City"), an Oregon municipal corporation, is soliciting bids from manufacturers and distributors to sell/provide City an aeronautical fuel tank (the "Tank") subject to the following specifications and requirements:

Fuel Tank Specifications

- 1. 20,000-gallon cylindrical, horizontal double wall UL-142 Jet A fuel tank consisting of SA 36 carbon steel construction. Tank must have primary and secondary emergency vents and a standard vent.
- 2. Tank must have a 3" non-carb ground level fill. Tank must also have a ground level fill spill pan with hand pump. Tank must have an automatic shutoff valve.
- 3. Other Tank components include the following: (a) one 20" manway per UL 142; (b) two 10" flanged nozzles (primary and secondary emergency vents); (c) one 6" CL150 RFSO flanged nozzle (GLF); (d) six 4" FNPT fittings; (e) four 2" FNPT fittings; (f) one 2" moniter tube; (g) one grounding lug; (h) two lifting lugs; and (i) two 4" high support saddles carbon steel.

Bid

A manufacturer or distributor interested in providing/selling the Tank must submit a signed and dated written bid to City containing the following minimum information:

- 1. Bidder's name, address, contact information, and the name of the primary contact concerning the bid.
- 2. Description of the proposed Tank, including, without limitation, Tank's composition and dimensions. Description of the Tank's warranty, including any warranty limitations.
- 3. Proposed Tank's availability (i.e., is the Tank immediately available?). Proposed purchase price for the Tank.



Proposal Submission

To be considered, please submit your bid to City Manager Daniel Brown via email at dbrown@cityofburnsor.gov or by mail or hand delivery at the City of Burns City Hall, Attn: City Manager, 242 S Broadway, Burns, Oregon 97720. Please mark clearly on the outside of your bid "Fuel Tank Bid." Bids must be received by City on or before 5:00 p.m. on March 7, 2022. Bids received after the deadline date/time may not be considered. Bidders responding to this request for bid do so at their own expense. City is not responsible for expenses associated with the preparation of any bids.

Any bid that is awarded will be made to the bidder whose bid will serve City's best interests, taking into account price and various other considerations. Notwithstanding anything contained in this request for bid to the contrary, City reserves the right to, in accordance with Oregon law, (a) amend and/or revise this request for bid in whole or in part, (b) cancel this request for bid, (c) extend the submittal deadline for responses to this request for bid, and/or (d) reject all bids for any reason and/or without indicating reasons for rejection. Further, City reserves the right to seek clarification(s) from any bidder and/or require supplemental information from any bidder. City is not obligated to award or select any bid.
